THE SCOPE OF THE ROUNDTABLE

2. Evolution of the current model of diplomacy: traditions and innovations.

SUBMISSION GUIDELINES

In order to participate in the Roundtable please email to **mv.conference2020@gmail.com** application and paper in Ukrainian or English language up to 4 pages which meet the formatting requirements (see below).

In addition, the authors without PhD are asked to submit a scanned copy of letter from their supervisor or an extract from the protocol of their department (school) meeting with recommendation for publishing.

The deadline for submission is November 30, 2020.

FINANCIAL ISSUES

Participation in the Roundtable is **free of charge** with no administration fee.

All expenses related to organization of the event and publication of the papers collection are covered by the Jean Monnet Module grant from the Education, Audiovisual and Culture Executive Agency of the European Commission.

FORMATTING REQUIREMENTS

Only papers related to the roundtable topics are accepted.

The file's title should include an author's name (Ivanenko_paper.doc or Ivanenko_application.docx).

File types: Word 6.0 and further version for Windows.

Page limits: max 4 pages (including references)

Your paper file must adhere to the following formatting requirements: A4 page portrait format (297x210 mm), margins – 20 mm; font – Times New Roman, size – 14, line spacing – 1,15, style – Normal, single-column format of the main text; the manuscript must be justified alignment; there should be no endnotes; do not number the pages or include line numbering.

A paper should use in-text citation. A direct quotation should include the number of a source in the list of references and the page number, for example [2, p. 65].

The list of references should be provided after the main body of text (rubric 'References'). The list of references should be indexed (1, 2, 3...) and use APA, MLA, OSCOLA or Chicago Style for the bibliographies.
