Requirements for a Research Proposal
for applicants to study for the degree of
Doctor of Philosophy in the specialty C1 Economics and International
Economic Relations (by specialization)
Educational and Research Program "International Economic Relations"
(full-time and part-time forms of education)

Research proposal is a scientific text of up to 5 pages, prepared by an applicant, in which the topic of the future dissertation research, its relevance, the state of development in domestic and foreign science; possible ways of solving the tasks, etc. are substantiated.

Applicants submit a research proposal along with their application for admission to the Ph.D. program.

The research proposal should contain:

- relevance of the research topic, the relevance of the topic to the current state of science;
- state of development in domestic and foreign science, highlighting the unresolved aspects of the selected issues;
- purpose and objectives of the research;
- object and subject of research;
- methodology and scientific research tools;
- research source base, potential sources of primary information.

Formatting requirements: the text of the research proposal is typed on a computer at one and a half intervals on standard sheets of A4 format. Margins: on the left side - 30 mm, on the right - 15 mm, on top - 20 mm, on the bottom - 20 mm. Paragraph indentations should be the same everywhere - 10 mm. The text is printed on one side of the sheet (with black paint of medium thickness). Font – Times New Roman, size – 14 pt.

The presentation of the research proposal takes place in the form of an interview at a meeting of the subject committee.

The results of the presentation of the research proposal are evaluated on a 200-point scale.

The relevance of the proposed research topic is fully substantiated, a comprehensive overview of research on the selected topic is presented, the research proposal contains all the necessary components, the provisions stated in the research proposal do not repeat and do not contradict each other, the applicant showed deep knowledge of theoretical and practical aspects of the program material, comprehensive, consistent and competent presentation.	175 - 200
The relevance of the topic of the intended research is substantiated, a comprehensive overview of research on the selected topic is presented, the research proposal contains all the necessary components, the provisions stated in the research proposal do not repeat and do not contradict each other, the applicant showed thorough knowledge of the main issues of the program material, logical and competent presentation, did not make any significant mistakes in the answers.	145 - 174
The relevance of the topic of the intended research is not fully substantiated, the review of research on the selected topic is not sufficiently thorough, the research proposal contains all the necessary components, the entrant showed knowledge of only the key issues of the program material, inaccurate phrasing.	125 - 144
The relevance of the proposed research topic is not fully substantiated, the review of research on the chosen topic is superficial, the research proposal contains all the necessary components, but they are not fully disclosed, the entrant showed incomplete knowledge of the main issues, understands the material only in a general form, inaccurate phrasing, the sequence of presentation is broken.	100-124
The relevance of the proposed research topic is not substantiated, there is no review of research on the selected topic, the research proposal does not contain all the necessary components, the provisions stated in the research proposal are repeated or contradict each other, the applicant showed ignorance of the key issues of the program material, makes significant mistakes.	less than 100

Applicants who score less than 100 points on a scale of 100-200 receive an unsatisfactory grade and are not allowed to participate in the competition.
